Then after he injured his forearm, he has worked for Fort Bragg and now he is employed at a truck driving industry. Now both of my parents live in Fayetteville, North Carolina and have raised my sister and me and also have adopted a younger brother, 5 years ago. We have lived in Fayetteville all of my life and have been lucky to have not moved around a lot due to my father being in the military.

Perceptions of Parents Attitudes
